2. The daily fee per day means a daily fee irrespective of number of cases.
3. The claim per day while leaving Head Quarter on appearance matters need to be processed separately and the above approval relates to the appearance fee at the court concerned on dates of hearing of the case.

The remaining terms and conditions as indicated in this Department's earlier Notifications will remain the same.
