No. JDJ.89/2018-ESTT.-JUDI-Judicial/44: On the recommendation of the "Second National Judicial Pay Commission" on interim relief, the Governor of Assam is pleased to allow interim relief to the Pensioners and Family Pensioners of the Assam Judicial Service as follows:-

- 1. Interim relief to the extent of 30% of increase in basic pension shall be paid to all pensioners and family pensioners of Assam Judicial Service w.e.f. 01.01.2016.
- 2. The basic pension increased by 30% shall be treated as a separate component and no D.A./D.R is payable on this component of pension. However, the D.A./D.R. at applicable rates with reference to the existing pension will remain intact till the new pension scales recommended by the Second National Judicial Pay Commission.

The above benefits are subject to the following conditions:

- a) Strict adherence of Para 5 of the Recommendation of the Second National Judicial Pay Commission, wherein it is stated that whatever the benefit of interim relief has already been granted, the Judicial Officers in those States can exercise their option to continue to be governed by such orders;
- b) Adjustments of the amount payable by way of interim relief against the future determination pursuant to the final report submitted by the Commission.

This is issued as per no objection conveyed by Finance (EC-III) Department vide their U/O No.781/2019, dated 03/12/2019.
