NOTIFICATION

Dated Dispur, the 1st August, 2015

NO. JDR.53/97/70: In partial modification of this Department's Notification No. JDR. No.53/97/35, dated 19-1-2009 the Governor of Assam is pleased to enhance the retaining fees and daily fees of Government Pleaders/ Assistant Government Pleaders and retaining fees and daily fees of Public Prosecutors/ Additional Public Prosecutors and Assistant Public Prosecutors as shown below for conducting Criminal cases, irrespective of number of cases or appeals in a day as follows, w.e.f. the date of issue of this Notification.

DISTRICT AND SUB-DIVISIONAL COURTS

(A) RETAINING FEES

Retaining Fees	Existing Rate	Enhanced Rate
1. Public Prosecutors and Government Pleaders	Rs.4000/- P.M.	Rs.8000/- P.M.
2. Additional Public Prosecutor	Rs.3000/- P.M.	Rs.6000/- P.M.
3. Assistant Public Prosecutors and Assistant Government Pleader.	Rs.2000/- P.M.	Rs.4000/- P.M.

(B) DAILY FEES

Daily Fees	Existing Rate	Enhanced Rate
1. Public Prosecutors and Additional Public Prosecutors	Rs.800/- per day	Rs.1600/- Per day.
2. Assistant Public Prosecutor	Rs.700/-per day.	Rs.1400/- per day

(C) BAIL MATTER

Daily Fees	Existing Rate	Enhanced Rate
1. Public Prosecutors and Additional Public Prosecutors	Rs.250/- per day	Rs.500/- Per day.
2. Assistant Public Prosecutor	Rs.200/-per day.	Rs.400/- per day

TERMS AND CONDITIONS:-

1. Appointment/ Engagement of Govt. Advocates shall be for one year at a time and renewable only after satisfactory performance.
 2. The correspondence/communication of the Court matters should be made by Govt. Advocates direct to the concerning Administrative Department with a copy to the Chief Secretary, Assam and Judicial Department.
 3. The bills of Govt. Advocates shall be submitted on monthly basis so that the requirement of fund can be assessed by Judicial Department.
 4. Administrative Department shall maintain a Registrar of all Court cases with minor heads, Drafting, Filing, Appearance etc. so that the bills once cleared are entered into the Register to avoid duplicacy.
 5. Public prosecutors, Addl. Public Prosecutors and Asstt. Public Prosecutors will get one daily hearing fee irrespective of number of cases conducted by them in a day plus one daily hearing fee of bail matters if conducted on that day.
 6. In case there is no effective hearing in a day, they will get adjournment fee as per existing provision for that day plus one daily hearing fee of bail matter if conducted on that day.
- Necessary amendment in the Assam Law Department Manual is being made accordingly.


