No. JDJ.9/2020/6: On recommendation made by the Hon'ble Gauhati High Court vide letter No.HC.VII-121/2019/534/A, dated 23.01.2020, pending satisfactory police verification report, the Governor of Assam is pleased to appoint temporarily the following twelve (12) candidates in the Grade-III of the Assam Judicial Service in the usual scale of pay. However, in the event of any adverse police verification report in respect of any candidate, his / her appointment will be canceled forthwith.
