ORDER

The following are the Terms and Conditions of service for the appointee:

1. During his service period, he may be deputed or his services may be placed on attachment or on secondment basis to any other department/sub-ordinate office/ public sector undertaking /society/ Mission under the State Govt. within

While on such Deputation or on attachment or placed on Secondment basis, he shall continue to be guided by the Assam Civil Services (Conduct) Rules, 1965 and Assam Services (Discipline & Appeal) Rules, 1964.

2. The service of any selected candidate who is found to have furnished false/ falsified information regarding educational qualification/ caste/ gender/ EWS status etc. in his application and detected subsequently, will be terminated and legal action will also be taken as per law.
3. If a Candidate or any of his family members is availing benefits under the Orunodoi Scheme at the time of the appointment, he or the concerned family member shall voluntarily opt out of the Scheme, as per Orunodoi Guidelines for getting appointment to the post.
